I have started and driven my vehicle with the spare key to ensure that it works.

I will remove all open containers of alcohol or other illegal items so that the driver of my vehicle will not be charged in case the vehicle is inspected. _____

In case my vehicle becomes inoperable, unsafe, or unlawful for any reason, BBC Shuttle LLC will let you know where your vehicle is. No refunds will be allowed if the vehicle or trailer is unsafe. I have included above an amount I am willing to pay to complete the shuttle if a repair is needed. _____

I understand that the roads driven may be rough and poorly maintained and I will not hold BBC Shuttle LLC responsible for the damage done to the vehicle while en route or parked. Permission is hereby granted to drive the vehicle above and it is covered by public liability and property damage insurance that will cover the vehicle and the shuttle driver. If it does not, I understand that I am liable for charges resulting from any deficiency in coverage. _____

I ensuring that all our party vehicles have a full gas tank. You may also leave the instructions above and funds in the locked vehicle for our shuttle drivers to refuel. I will ensure that all vehicles are working properly and safely. We will check all fluids (oil, transmission, water), and my vehicle is in good driving condition for the rough and unpredictable roads to your chosen takeout destination.

We will not shuttle vehicles without a real tire as a spare. Please make sure that the spare is easily accessible. If the vehicle is left with bald tires at the launch, BCC Shuttles LLC has the right to leave it and charge our full fee. _____

Automobile Shuttle Waiver of Liability and Acceptance of Risk: Driving a vehicle has inherent risks. The persons hired by BBC Shuttles LLC to drive the vehicle are independent contractors. Drivers are instructed to drive carefully and always obey traffic laws. I am aware the roads in the area may be rough and poorly maintained and the roads may include danger beyond the driver's control. Because of the risks of driving and possibility of negligence on the part of BBC Shuttles LLC or persons operating the vehicle for BBC Shuttles LLC, all services provided under this agreement are at the vehicle owner's sole risk. The vehicle owner/operator shall forever indemnify and hold harmless BBC Shuttles LLC and the persons operating the vehicle for shuttle service against any and all loss, cost, claim or damage and account for any injury or damage to persons or property arising out of the performance of this contract. The vehicle owner/operator acknowledges this risk and waiver of liability shall serve as a release, discharge, and acceptance of risk for my heirs, estate, executor, administrator, and assigns all members of the vehicle owner/operator's family.

Insurance Release Clause: The vehicle owner/operator hereby covenants and warrants that the vehicle has full collision insurance and liability insurance in the minimum amount required by the laws of the State of Idaho. Vehicle owner/operator thereby acknowledges that neither BBC Shuttles LLC nor the persons operating the vehicle have any liability, comprehensive or collision insurance covering the vehicle owner/operator's vehicle and property and agrees to forever indemnify and hold harmless BBC Shuttles LLC and the persons against all loss, cost or damage on account of any injury or damage to persons or property arising out of the performance of this contract and the operation of the vehicle owner/operator's vehicle by BBC Shuttles LLC and the persons operating the vehicle. Vehicle owner/operator voluntarily consent to accept all risks associated with participation.
